

## **2020 CAMBRIDGE INTERNATIONAL EXAMINATION ENTRIES for PRIVATE CANDIDATES**

Private candidates who intend entering for the May/June 2020 Cambridge International Examinations through ISCT should please complete the 2020 electronic entry Google form (link on Due Dates info sheet) **by Monday 20 January 2020.** 

We will only upload a candidate's exam entry once the fee has been paid. We reserve the right to close entries early if the centre reaches capacity.

NOTE: \*Please contact us directly when wishing to enter for subjects with a practical component as our numbers are limited by space. The additional fee covers materials, setup, damages, additional expert supervisor/examiner, as required by Cambridge.

If additional assistance (such as Practical Examination preparation for a Science subject is required), group tutor sessions may be possible to arrange. Any such services we are able to offer will be charged separately. Please contact us directly regarding any such needs.

### **INFORMING US OF STUDENTS WITH ASSESSED NEEDS**

Parents or tutor schools with students who have particular professionally assessed needs must inform us directly via email (<u>cambridgeexams@isct.co.za</u>) **on application** and lodge supporting documents with us when submitting the exam entry form, in order for us to make the application to Cambridge. Assessments need to have been completed within the last 3 years. If medically or psychologically recommended accommodations (such as a separate exam venue) require additional personnel, an additional cost will be charged. This fee will be determined by the number of papers to be written. Please note: as our exam facilities are limited, we may not be able to support all access arrangements.

### PAYMENT OF FEES

Failure to pay the entry fees timeously will prevent your entry from being submitted. If withdrawals and corrections are not communicated timeously, or entries are made after the above dates, each change will incur the late penalty fee which is charged by Cambridge (see table overleaf). If you have any queries regarding the above or regarding codes and subject details when filling in the entry (Google) form, or total costs, please feel contact us via email.

### Fees are payable on registration.
