Private candidates who intend entering for the May/June 2023 Cambridge International Examinations through ISCT should please complete the 2023 <u>electronic entry Google form</u> by Monday 17 January 2023.

An invoice will be generated and emailed to you. We will only upload a candidate's exam entry once the fee has been paid. We reserve the right to close entries early if the centre reaches capacity.

PAYMENT OF FEES

Failure to pay the entry fees timeously will prevent your entry from being submitted. If withdrawals and corrections are not communicated timeously, or entries are made after the above dates, each change will incur the late penalty fee which is charged by Cambridge (see table overleaf). Fees are payable on registration.

These fees cover the subject exam fees, payment of invigilators for each paper written, venue hire costs, exam materials, couriering of all exam papers, all meeting Cambridge Assessment requirements, as provided by ISCT.

Examples of exam entry totals:

The total fee for a typical private AS student entering 4 AS subjects, including Physics, will be R9500. The total fee for a typical private IGCSE student entering 6 subjects will be R11600.

NOTE: *Please contact us directly when wishing to enter for subjects with a practical component (AS Sciences) as our numbers are limited by space. The additional fee covers materials, setup, damages, additional expert supervisor/examiner, as required by Cambridge.

If additional assistance (such as Practical Examination preparation for a Science subject is required), group tutor sessions may be arranged. Any such services we are able to offer will be charged separately. Please contact us directly regarding such needs.

Due date for full payment of the examination fees into the ISCT bank account: **Tuesday 01 February** Date on which ISCT will upload the entries to Cambridge: **Tuesday 01 February**.

INFORMING US OF STUDENTS WITH ASSESSED NEEDS

Parents or tutor schools with students who have particular professionally assessed needs which require exam access arrangements must inform us directly via email (cambridgeexams@isct.co.za) on application and lodge supporting documents with us when submitting the exam entry form, in order for us to make the application to Cambridge by the deadline. Educational Psychological assessments need to have been completed within the last 3 years. If educational, medical or psychological recommended accommodations require additional personnel or additional time, an additional cost is charged. Please note: as our exam facilities are limited, we may not be able to support more specialised access arrangements, such as a fully separate venue or a reader.











FINAL STEPS ONCE YOUR ENTRY IS CONFIRMED

- The provisional statement of entry will be sent to you for you to confirm whether <u>ALL</u> details are correct. Notify us via email (<u>cambridgeexams@isct.co.za</u>) of necessary amendments **immediately on receipt** of the statement of entry. We cannot be held responsible for entry errors that should have not been identified by you. Errors requiring amendment which are identified after 14 February will incur the late penalty fee by Cambridge so please inform us BEFORE that date.
